Personal Statement

As an HIV clinical pharmacist and research coordinator in both a Ryan White HIV/AIDS clinic and a health-system specialty pharmacy in South Florida, I have had the privilege of working at the intersection of direct patient care, program development and health policy in HIV. My work spans rapid implementation of services — from launching COVID-19 and mpox vaccination/treatment initiatives to integrating long-acting injectable therapies, HIV/HCV opt-out testing and increasing HIV PrEP/PEP access in both hospital and clinic settings. These



programs often required collaboration across hospital, county, state and national levels — giving me insight into the real-world impact of policy on patient outcomes for persons with HIV. Over the years, my advocacy experience has extended from the patient's bedside to congressional offices, collaborating on antiretroviral stewardship programs, contributing to national publications and helping shape equitable access to HIV services amid evolving 340B policy changes. My unique hybrid role has allowed me to not only see but also influence how systems-level decisions and policies affect patients and providers. I would be honored to join the HIVMA Board to bring forward the voices of patients and providers, advocate for equitable access and help shape solutions that are both practical and patient-centered. I bring passion, front-line experience and a deep commitment to ensuring HIV care evolves with empathy, evidence and equity.

Personal statement

I am grateful for the opportunity to serve on the HIVMA Board. As a physician working in a rural part of the United States — southwestern Arizona and a border town — I think I bring a unique perspective to our leadership. Now more than ever we need strong advocacy for



patients with HIV during these tumultuous times. I think I can be a voice for clinicians working in rural communities who do not have the advantages of practicing in large academic and resource-rich settings. As an employee of a federally qualified health clinic, I work daily in a community that struggles with financial hardship, limited resources and minimal access to the most advanced research or studies. I care for a diverse group of patients: More than 50% are aging, and many are undocumented; unstably housed; struggling with substance use, inadequate mental health support and care; and are patients from the Native American lands. I also have found it uniquely challenging to recruit HIV providers and retain talent. However, I remain optimistic and enthusiastic about the opportunities that lay ahead and working with partners at the local, state or national level to advance our mission of caring for those most underserved in a very meaningful and sustainable way.

Personal statement

My career in pediatric HIV began in 2009 in a PEPFAR-funded program in Gaborone, Botswana, where I assisted the Ministry of Health in scaling up antiretroviral access for youth across the country. Since that time, my clinical and academic work has focused on the



prevention and treatment of HIV in urban youth populations with an emphasis on community interventions to sustain care engagement. Inherent in this work is the need for advocacy, stigma reduction and psychosocial supports. At a time when the funding landscape for this essential work is threatened, I can think of no better way to contribute to the discussion than to seek a role on the HIVMA Board of Directors. I desire to work with like-minded colleagues from across the nation to amplify the voices of our youth communities with HIV, seeking to identify the unique identities that they possess, advocate on their behalf and aid in crafting interventions that speak to them. My experiences working with youth with HIV give me a unique perspective on their positioning within the care continuum, and I look forward to influencing policy with their concerns and needs made a priority as a member of the Board of Directors.

Personal Statement

For more than 20 years, I have championed efforts for populations disproportionately affected by HIV to have access to prevention strategies and receive optimal care. As a clinician, I became a community activist promoting HIV education and testing and demystifying clinical trials to make them more inclusive and relevant to marginalized communities. I spent a decade as the program director for pregnant women with HIV and perinatally infected adolescents at Bellevue Hospital, the largest public health hospital in NYC. There I had the unique opportunity to gain insight into HIV health care delivery in marginalized subpopulations including the homeless, patients with substance use and mental health disorders, incarcerated individuals and undocumented immigrants. My research career developed using the infrastructure of the ACTG. As the principal investigator of the clinical site co-located with Sinai's Center for Transgender Medicine and Surgery, I recognize the value of ensuring that members of all vulnerable communities have a seat at the table, from deciding priorities to best practices for implementation. My years of work with HIVMA, including service as its chair, have provided me the opportunity visit lawmakers on Capitol Hill to advocate for the necessary funding to end the HIV epidemic. I am passionate about expanding the workforce of providers dedicated to quality, compassionate care by creating novel strategies to combat the epidemic and educate providers in areas hardest hit by the epidemic. I will offer the IDSA Board a broad perspective on patient care delivery within the constraints of federal and state funding issues given my experience treating diverse populations and novel initiatives to prevent the cascade.
